

- ii) To purchase or take on leave vacant lands, plots, building, buildings, to let out the same and to recover rent and profits there from, to renovate old structures and buildings, to whit-wash them and to effect minor or major repairs.
- iii) To dispose of old and unwanted properties of the trust subject to provisions of the Bombay Public Trust Act, 1950.
- iv) For the fulfillment of the aims and objects of the trust to raise loan from any financial institution with or without security, to execute necessary documents or authorize any trustee or office bearer to do so, subject to the provisions of the Bombay Public Trusts Act, 1950.
- v) For the fulfillment of the aims and objects of the trust to accept donations on condition or unconditional, to accept gifts, grants, subscriptions contributions by way cash and kind.
- vi) To appoint permanent or temporary employees as per requirements for managing day to ay management and administration of the trust and its branches.
- vii) To frame service rules regarding salary, workload, etc, by adhering the law in that respect.
- viii) To check income and expenditure of the trust and branches and apply funds towards aims and objects of the trust, to invest surplus funds and provided in the Bombay Public trust Act, 1950.
- ix) To open, Conduct branches of the trust at places as may deem fit and proper and keep full control over such branches.
- x) To give financial aid to branches for fulfillment of the aims and objects of the trust.

- xiii) To start and conduct orphanages to provide orphan children nutritious food, cloth, shelter, school and college aid and equipments and assist by way of cash or in kind.
- xiv) To establish and conduct aid camps and centers for the rehabilitation of sufferers and affected persons by natural claimants or civil commotion.
- xv) To arrange seminars, symposiums, lectures on various subject.
- xvi) To establish and conduct yoga, sadhana classes, to propagate importance of yoga-Vidya and try to achieve mental peace.
- xvii) To establish and conduct hospitals, maternity homes, dispensaries with a view to assist poor and give them solace and relief.
- xviii) To arrange various sports competitions, dramatic activities, fine arts.

#### 13. Powers of the president.

- President of the general body will be the president of the trust(if there is general body)
- ii) President will preside over all the meetings of the general body of trustees.
- iii) The president will generally supervise all the activities of the trust.
- iv) The president has right to distribute work for the sake of convenience of the daily routine of the trust.
- v) To ask the secretary to call meeting of the general body or board of trustees.

- iv) All monies received or collected by the trust or branches should be deposited in bank accounts immediately or as early as possible.
- v) The Treasurer or secretary will not keep at one time on hand, more than Rs.10,000/-

#### 17. Financial Year:

Finance of the trust and its branches will commence from the 1<sup>st</sup> of April of every year and will end on every 31<sup>st</sup> March of every succeeding year as per the policy of the Government for the sake of uniformity.

#### 22. Legal Proceedings:

The Board of Trustees may initiate legal action if and when necessary for the protection of trust properties and interest of the trust. If the legal action is taken against the trust, Board of Trustees may defend the same and for the said purpose

24. Provision Regarding amount no recovered:

If any amount have to be recovered by trust or if any trustee or member or outside person have dues towards trust then as per provision of Maharashtra public Trust Management Act, 1950 will be applicable to suits by charity and against trust. Likewise to the suits by trust & to the suits against charity or to the suits of trustees or others sec. 50 Maharashtra public trust Act, 1950 will apply.

25. Winding up: the winding of trust will be done as per sec.22(3) of Maharashtra Public Management Act, 1950. For the winding of trust a written consent of at 3/5 members out of total members of trust will be necessary. After winding the balance amount, asset of trust will be amalgamated in the trust having same purposes. Likewise changes in the name or purposes of the trust of for the amalgamation will be done as per provision of sec 50(A) (2) of Maharachtra Public Trust Management Act, 1950.


